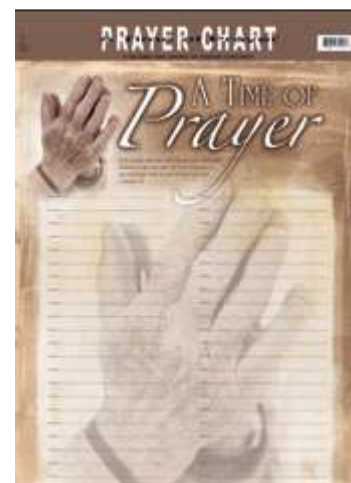
Chrysalis Butterflies
